SUBJECT:

Striping Modification at the Intersection of Eolus Avenue, Hillcrest Drive and Andrew Avenue

RECOMMENDED ACTION:

Please provide input to staff on an alternate solution for the approved All-Way Stop Control at this intersection

BACKGROUND:

The City has received several requests from the residents to evaluate the safety and mobility at the intersection of Eolus Ave, Hillcrest Dr and Andrew Ave.

Staff conducted evaluations per CA-MUTCD guidelines, and the intersection met the warrants recommended by MUTCD to be converted to an All-Way Stop Control (AWSC) Intersection. Traffic and Public Safety Commission approved the AWSC in May and the City Council approved the AWSC after.

When staff began programming the installation, a group of residents asked staff and City Council to evaluate alternate options to minimize the impact on the residences immediately adjacent to the intersection. The City Council directed staff to provide feasible alternative options.

ANALYSIS:

Staff met with the residents several times and have come up with some alternatives that can improve and enhance safety and mobility at this intersection. One of the options is to realign the legs of the intersection and form a 90-degree angled "T" intersection that clarifies the fact that Andrew Ave and Eolus Ave are the continuation of each other and Hilcrest is the intersecting roadway. A Yield line accompanied by proper signage can clarify the ROW at the intersection for different approaches and the new striping modification can resolve the sight distance issue at the intersection. The proposed design is shown in attachment 1.


Before reaching out to the residents on the alternate option, staff asks Traffic and Public Safety Commission to provide input on this alternate scenario. If supported by TPSC and by residents, this alternate scenario will go back to the City Council for approval, replacing the AWSC that was previously approved by the City Council.

ENVIRONMENTAL CONSIDERATIONS:

The proposed intersection improvements are considered a minor alteration as is exempt from provisions of California Environmental Quality Act (CEQA)
